

OBJECTIONS ON PROVISIONAL ANSWER KEYS

Provisional Answer Keys of all the four Question Paper Booklets (Set A, Set B, Set C and Set D) along with Images of OMR answer Sheets of candidates have been uploaded on **1st November 2021**. Objections / Clarifications, if any, can be sought up to **05-11-2021 by 4.00 PM**. Subsequently, the final answer key will be published which will be binding on all the candidates and no further claim / clarification would be entertained thereafter.

Guidelines for Candidates seeking any clarifications with regard to Provisional Answer Keys

- a) Apply online (**ehelpdesk2@gmail.com**) to **THE PUNJAB STATE COOPERATIVE SUPPLY & MARKETING FEDERATION LIMITED (MARKFED)**, clearly indicating the grievance and relevant objection(s) along with all necessary enclosures in the prescribed format (**Ref : Annexure-I for format**) which can be downloaded from **THE PUNJAB STATE COOPERATIVE SUPPLY & MARKETING FEDERATION LIMITED (MARKFED)** website.
- b) Clarification regarding provisional answer key should reach **THE PUNJAB STATE COOPERATIVE SUPPLY & MARKETING FEDERATION LIMITED (MARKFED)**, Chandigarh office by **online mode only** giving complete details of the non refundable demand draft of **Rs. 118/- (Rupees one hundred eighteen only) per clarification**, drawn in favour of the '**THE PUNJAB STATE COOPERATIVE SUPPLY & MARKETING FEDERATION LIMITED (MARKFED)**' payable at Chandigarh.
- c) The non-refundable demand draft should be sent by speed post to **The Establishment Officer (G), MARKFED H.O., Plot No.4, Sector 35-B, Chandigarh.**
- d) No request for clarification of provisional answer keys beyond the last date (05-11-2021 by 4.00 PM) as stipulated on the **THE PUNJAB STATE COOPERATIVE SUPPLY & MARKETING FEDERATION LIMITED (MARKFED)** Chandigarh website will be entertained.

Note: Seeking clarification as above is only for provisional answer keys. Such clarifications will not be entertained after the publication of Final answer keys.

Any verifications / clarifications sought by the candidate will be put forth to the duly constituted expert committee(s) of the Examination Conducting Authority for their consideration. The decision of the expert committee(s) shall be binding to all the stakeholders and no further clarification shall be entertained at any level. The final result shall be prepared based on the finalized answer key(s).
